- _____ I have read the Parent Handbook for GMPS and agree to adhere to all policies and procedures.
- _____ I have read the **Guidance/Discipline/Communicable Policies** outlined in the Handbook and agree to adhere to them.
- _____ I have read the **Peanut/Nut-Free Snack/Lunch Policy** and agree to adhere to all policies, precautions and restrictions. This includes providing snacks from the approved snack lists and avoiding all peanut/nut related products.
- _____ I have read the **Late Pick Up Policy** and agree to adhere to the policy. This includes paying fine of \$20 plus \$1/per minute past the 15 minute grace period will be levied, with a maximum fine of \$60.
- _____ I have read the **Tuition/Enrichment Payment Schedule and Late Payment Policies** and agree to adhere to these policies. I understand that tuition will be billed in three equal payments (Sept. 1, Dec. 1 and Mar.1) and Enrichment fees billed on the 1st day of the month of the session. Any balance due will be automatically charged to my provided payment method on the 10th of the month due. I further understand if tuition payments are not paid by the 21st day of the month due, a 2.5% per day penalty will be applied. Additionally, if any tuition or late fees are over 35 days late, your child will no longer be able to attend class until the account is made current.
- _____ I agree that, if necessary, Glenview Methodist Preschool may discuss pertinent information about my child with other educational facilities. Information exchanged will be kept confidential.
- _____ I hereby authorize Glenview Methodist Preschool to take photos of my child for publicity purposes without any compensation to me or my child.
- _____ I hereby give consent to Glenview Methodist Preschool, Inc. to take my child on walking trips in the neighborhood and special excursions. I understand that such trips are under the supervision of authorized personnel of the school and that all possible precautions are taken to ensure the health and safety of my child.
- _____ The Preschool provides babysitting for students and their siblings during conferences and for guest speakers. I hereby absolve Glenview Methodist Preschool from any financial responsibility in case of accidents when leaving a child/children in the care of the babysitting services provided by the Preschool during these functions. This is with the understanding that the children will be under responsible supervision and that all possible precautions are taken to ensure the health and safety of the children.
- _____ GMPS is aware that teachers occasionally enter into separate agreements with parents for childcare after school hours. Parents entering into such agreements with teachers or otherwise engaging or permitting teachers to render childcare services for their child(ren) understand and agree that such agreements or arrangements are solely and exclusively between such teachers and such parents.
- By signing below I volunteer to waive any claims against GMPS arising in the scope of, or relating in any way to, such agreement or arrangement and expressly agree to indemnify, defend, and hold harmless GMPS against any such asserted claims including, but not limited to, any claims of personal injury or negligence brought by or on behalf of any person against GMPS.

This waiver and release includes, but is not limited to, any acts, occurrences, or omissions occurring outside of the GMPS building (including, but not limited to, the parking lot).
